Accredited Training Program (ATP) 1 August Deadline Extended!—After 1 January 2019 (formerly 1 August 2018), **all exam review courses** must be delivered by an accredited trainer or a trainer who is at least in the process of becoming accredited. ATP program details can be found [here](#) in the Chapter Leader Portal. Note the link to the “FAQs” at the top of the page.

CPE Reporting for Chapter Leaders—Chapter leaders must enter their own CPE hours specific to their service (which can be claimed in the category of “Working on an ISACA Board/Committee/Chapter”), as they would for any other CPE-qualifying activity. Chapter leaders may claim up to 20 CPE hours annually for their service as a chapter leader. Should you be audited, you will **not** be required to provide verification for your volunteer hours, as ISACA continues to maintain record of your service. As a reminder, you can add CPE hours at any time throughout the year, which makes it easier to track CPE hours as you earn them.
